

**SUMMARY ANNUAL REPORT FOR  
STANLEY BLACK & DECKER, INC. HEALTH & WELFARE PROGRAM**

This is a summary of the annual report of the Stanley Black & Decker, Inc. Health & Welfare Program (Employer Identification Number 06-0548860, Plan Number 550) for the plan year 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Stanley Black & Decker, Inc. has committed itself to pay certain health, dental and vision claims incurred under the terms of the plan.

**Insurance Information**

The plan has insurance contracts with Anthem Health Plans, Inc., Cigna Health and Life Insurance Company, Eyemed Vision Care, Arag Insurance Company, Unum Life Insurance Company of America, Securian Life Insurance Company, Life Insurance Company of North America, Ace American Insurance Company, Connecticut General Life Insurance Company, Kaiser Foundation Health Plan Inc, Kaiser Foundation Health Plan Inc. and Hawaii Medical Service Association to pay certain health, indemnity contract, dental, HMO contract, prescription drug, vision, pre-paid legal, long-term disability, life insurance, accidental death and dismemberment, business travel accident, voluntary critical illness, hospital care, accidental injury, PPO contract claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2022 were \$21,871,726.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2022, the premiums paid under such "experience-rated" contracts were \$35,518 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$31,588.
